Clinical Faculty Calibration on Radiographic Prescriptions and Assessment CE: 1

Abstract: The ADA/ FDA created a guideline to provide dentists with a strategy for ordering radiographic examinations for patients seeking care, while at the same time minimizing radiation exposure. However, now a days there are multiple dental clinics/schools where this guideline is not followed. Consequently, we encounter cases of patient's overexposure and unjustified or even incorrect ordering of radiographs (conventional or CBCTs) without proper previous clinical evaluation to accurately determine the appropriate type and time frame between radiographs. The audience will be calibrated in regard to when and what type of radiograph is appropriate to order on an individual patient basis.

Implementing the ADA Clinical Pain Guidelines in Dental Education Programs CE: 1

Abstract: This session focuses on opioid prescribing stewardship in dental education programs. The purpose is to disseminate evidence and strategies for implementing opioid stewardship in educational programs. The status of the opioid epidemic and role of dentists in managing orofacial pain will be provided. Development of the ADA Clinical Pain Guidelines (CPG) and the synthesis of the evidence for acute orofacial pain control will be presented. Strategies for implementing the CPG in predoctoral and postgraduate educational settings will be discussed. Participants will gain understanding of the evidence underlying the CPG and how to integrate them into teaching acute orofacial pain control.

Translating Evidence Based Tobacco Cessation Practice from Classroom to Chairside CE: 1

Abstract: Dental professionals are in a unique position to promote tobacco cessation. Literature describes, however, that dental professionals do not feel adequately prepared to counsel smokers. Patient-centered behavioral guidance is a well-recognized evidence-based interprofessional intervention to improve patient self-management towards common risk-factors including smoking. Providing patient-centered behavioral guidance to smokers will enhance patient outcomes and support value-based practice. Participants will learn how to develop a sustainable, evidence-based course to train dental students in tobacco cessation counseling based on motivational interviewing. This workshop describes transfer of skills to clinical practice and the impact of the intervention on patient satisfaction and quitting success.

Is the DAT all that? A DAT optional admissions debate (Limited to 10 Attendees)

Recruiting Students, Staff and Faculty: Do Implicit Biases Matter?

Abstract: In 2002, the Institute of Medicine published a ground breaking report called "Unequal Treatment" which showed that diagnosis, treatment and health outcomes were a function of age, sex and race. They reviewed over 600 studies concerning diagnosis, treatment and outcomes by age, sex and race. In Finding 4.1., they suggested that implicit bias was a plausible cause of race based inequities. The purpose of this workshop is to consider the role of implict biases in unequal recruitment of dental students, staff and faculty. Participants will be engaged in considering race-based differences in recruitment and exploring constructive changes in this situation.

Best practices for teaching of social determinants in the curriculum

Abstract: Social determinants of health (SDoH) significantly impact how individuals access and receive oral health care, making them key contributors to health disparities and inequities. Education regarding SDoH is imperative for the understanding of health inequities, and the appropriate and equitable delivery of person centered practice, yet a recent scoping review revealed a lack of comprehensive inclusion in SDoH in dental curricula. Moreover, there is a lack of guidelines for effective teaching of SDoH in the dental curriculum. This session will present best practices for teaching SDoH in the dental curriculum that participants can apply at their own institutions.

Apples to Oranges: Calculating Rigor Indices of Applicant Feeder Institutions CE: .25

Abstract: Optimal analysis for applicants to health science programs includes objective analysis of cognitive, non-cognitive, physical, and communication skills. There is an unspoken understanding that different feeder institutions have different academic

standards, thus the comparison between applicants for "high-stakes" decisions for admissions have historically included inherent biases. The need is to create a statistically verifiable method for making these important comparisons without such bias. In an endeavor to optimize the traditional cognitive skills, a machine-learning enhanced analytic was created to determine the relative "rigor" of each feeder institution (U.S. Patent No. 11,010,849). This session explores the implications of its implementation.

Abstract: Rangina Hamidi served as the last woman Minister of Education in Afghanistan until the return of the Taliban in August 2021. Concerned about the future of her 12-year-old daughter, Minister Hamidi left Afghanistan 8 days after the fall of Kabul, when all other leaders had left by Aug. 15.

Courageous and outspoken, she continues her humanitarian efforts in support of the education of girls and work of women. She is the co-author of Embroidering within Boundaries: Afghan Women Creating a Future, the winner of the Silver Medal in the Multicultural Category of the IBPA Benjamin Franklin Awards. The book tells the story of the entrepreneurial spirit and the embroidery social enterprise, Kandahar Treasure, that Minister Hamidi founded to assist women working within the cultural boundaries of Pashtunwali to earn a living and find a degree of self-determination in Kandahar, Afghanistan. The handcrafting of these exquisite tapestries, created by over 120 Afghan women, continues today and speaks not only to the beauty, talent, struggle and resilience

of Afghan women but also to the leadership possibilities of women and girls throughout the world if given the right tools.

The 2023 ADEA Tapestry Table® features a talk show format in which Minister Hamidi and ADEA's Chief Diversity Officer, Dr. Sonya Smith, discuss Minster Hamidi's life, the importance of the United Nations Sustainability Development Goals (UN SDGs) on gender equality and quality education goals, and how investing in these goals for women and girls as a collective global strategic priority are the keys to unlocking other key UN SDGs, such as good health and wellbeing; eradicating poverty; reducing inequality; and securing peace, justice and inclusive institutions. Discussions will also include the critical need to develop programs for women and girls to ensure that more women leaders serve as key decisionmakers in areas such as global health and education. The audience will also have the opportunity to purchase copies of Embroidering within Boundaries with proceeds going to support Kandahar Treasure, the Afghan women's artisan social enterprise.

Non Traditional Opportunities to Consider for Enhancing Student's Clinical Education.

Observation Skills - using art-based practices to enhance dental training

CE: .25

Abstract: Medical students improve communication, performance, and diagnostic skills with the use of art-based-observation sessions during medical training. Dental training also involves improving communication, diagnostics, and observational skills. In dentistry, observation relates to recognizing shades, shapes, forms, and dental anatomy details. We hypothesized that dental students given art-based-observation training would improve their visualization skills. Thus, we assessed changes in observational acuity before and after the inclusion of an art-based-observation workshop and recorded students' perceived experiences with the sessions. We verified that after one session of art training, dental students improved identifying and using dental anatomy landmarks.

Evidence-based Approach to Teaching Scientific Literature

Abstract: A course in scientific literature analysis was developed for first year hygiene students using current scientific manuscripts to illustrate basic concepts in statistics and epidemiology. In-class presentations are tailored to follow the format of a research manuscript. Groups of students are assigned different manuscripts at the beginning of the course along with detailed rubrics explaining the responses required as well as a sample manuscript with detailed responses. Daily assignments are given to reinforce scientific concepts. Written feedback is given daily via Blackboard. Students present the results of their manuscript analyses to the entire class at the conclusion of the course.

Swept under the carpet: inequity and exclusion in assessment

CE: 1

Abstract: Black and LatinX students face inherent barriers in the structures that govern progress in K-12 education, higher education and dental school application processes. Inequitable assessments in dental school reinforce barriers faced by these individuals. There are 3 components to equity in assessment: intrinsic, contextual and instrumental. Intrinsic equity means that assessment tools minimize bias. Contextual equity occurs when there is fairness in the learning experience. Instrumental equity is present when the assessment results create growth opportunities for all. In this seminar, we will provide: (1) examples of inequity resulting from failure to adhere to these principles and (2) possible solutions.

LocalAnesthesiaVR: An Immersive Simulation System with Real-time Haptic Feedback CE: 1

Abstract: Local anesthesia is a core technique in the context of clinical education. Current dental simulation systems for local anesthesia provide little or no feedback to the practitioner and are expensive to acquire and maintain. In 2022 the NYU College of Dentistry designed and developed a virtual reality simulation system that was successfully rolled out to 400 students. This immersive VR-based simulation system provides real-time feedback through text, visuals, audio and haptics in a unique way for each individual user. In this program you will see a live demonstration of this system, assess its strengths, and learn about the students' experience.

Abstract: Nonprofit HR, consultants for the ADEA Climate Study, will share key findings from the inaugural ADEA Climate Study and baseline data collected.
